Bus Transportation Procedures for Students Riding a Bus:

A Bus Transportation Form must e completed using your home address.

If your child goes to a different address, other than home, you must fill out a "Request for Transportation to a Childcare Provider" form in the office.

The parent/guardian must come to the office or send a note in writing 24 hrs. in advance of any changes that need to be made to the child's transportation form. **Changes will not be made over the telephone.**

The parent or authorized adult must accompany the child to the bus stop ten minutes prior to the designated pick-up time.

A parent or authorized adult must step up to the bus door and present a photo ID to pick up the child at the bus stop.

The authorized person on your bus transportation form must be 15 years of age or older. Your child will not be released to anyone under the age of 15 year old.

If a parent or authorized adult is not at the bus stop for the Champions Student, he/she will be returned to Champions Preschool at Timberlane Learning Center and must be picked up by _____p.m. for morning session and by _____p.m. for the afternoon session.

Montgomery County Sherriff or Children's Services will be called to assist with finding parents of children who are left at school beyond the close of the school day.

If a parent or authorized adult is not at the bus stop on a recurring basis or your child has two (2) or more incidents on the bus, your child's bus privileges may be suspended. Absences due to bus suspensions are not excused and you will be responsible for transportation to and from school.
